### The Volunteer Income Tax Assistance (VITA) Program: In-Person Assistance

The VITA Program provides free assistance with e-filing Federal and state tax returns for qualified taxpayers prepared by trained, IRS-certified VITA volunteers. This service is available to households that generally earn \$57,000 or less annually and/or to persons with a disability. **Masks are required and are not provided on site. No filings are started after 3 pm.**

- Prior Year and Amended Returns

#### What to bring:

- All forms needing to be prepared (see above)
- Government-issued ID
- Social security cards or Individual Taxpayer Identification and birth dates for you, your spouse, and/or your dependents
- A copy of last year's tax return
- Letter 6419 (en-sp) – Advance Child Tax Credit Payments

- Total paid to day care provider and their tax ID number
- Information for all deductions/credits
- Information for other income
- For direct deposit or refund — proof of account and bank routing number
- Notice 1444-C, Your 2021 Economic Impact Payment

**Note:** Both spouses must be present if filing jointly and will each need to bring some of the required information listed above. For prior year tax returns, bring copies of income transcripts from the IRS (and state, if applicable).

**SC Thrive:** With SC Thrive, you can file your South Carolina State and Federal Taxes quickly, easily, and at no cost if your Adjusted Gross Income (AGI) is less than \$65,000 (\$95,000 if your filing status is married filing jointly).
